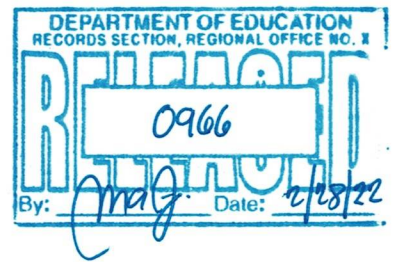

1. Through the Curriculum and Learning Management Division (CLMD), this Office will conduct a **two-day Strategic Planning and Prewrite** at NEAP, Lapasan, Cagayan de Oro City, on April 7-8.
2. The activity will help ensure that the participants adopt the appropriate and effective mechanisms in conducting the Focused Group Discussion (FGD) for 10-year program implementation assessment.
