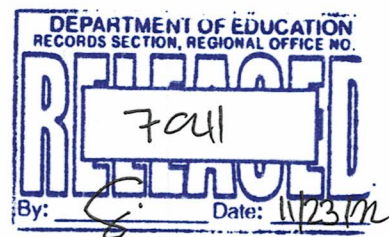

1. The Regional Office (RO) will conduct the **Seventh Regional Management Committee Meeting** to be hosted and facilitated by the Division of Cagayan de Oro City, at Chali Beach Resort and Conference Center, Zone 3, Cugman, on November 29, Tuesday, at 8:30 a.m.
2. The participants in this activity are the regional director, assistant regional director, schools division superintendents, assistant schools division superintendents, RO functional division chiefs, CID and SGOD chiefs, regional planning officer, and the secretariat.
3. Meals will include breakfast and lunch with morning and afternoon snacks.
