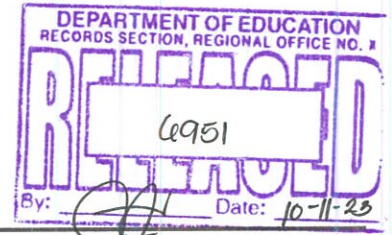




3. Travel expenses and other incidental fees shall be charged to the divisions' IPED funds and/or local funds, subject to the usual accounting and auditing rules and regulations.
