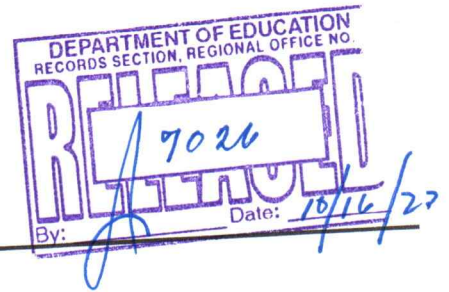

1. Regarding the implementation of the Special Education (SPED) Program, this Office will conduct the **Regional Training on the Use of Compendium of Teaching and Learning Resources for Filipino Sign Language (FSL)** on November 24-26. The venue will be announced through a separate issuance.
2. The participants are the proficient sign language teachers handling deaf learners.
3. Hence, all Schools Division Offices (SDOs) shall submit the list of participants to the Regional Office (RO) through email at [ellen.delante@deped.gov.ph](mailto:ellen.delante@deped.gov.ph). To confirm their participation, the participants shall register online via <https://tinyurl.com/Reg-FSLCompendium2023> on or before November 17.
4. Board and lodging shall be charged against downloaded funds while travel expenses shall be charged against 2023 SPED Program Support Funds and/or local funds, subject to the usual accounting and auditing rules and regulations. The first meal for the participants will be dinner on November 23, and the last meal will be lunch on November 26.
5. It is requested that service credit or compensatory time-off (CTO) be granted to the participants in lieu of the training day/s that will fall on either holidays or weekends in accordance with the CSC and DBM Joint Circular No. 2, s. 2004.
