**FRAUDULENT SCHEME OF PROMOTIONAL SALE OF AIRFARE
TICKETS WITH FREE TESTING OF COVID-19**

The Department of Health – Center for Health Development Northern Mindanao, through Dr. Adriano P. Suba-an, CESO IV, OIC-Director IV, forewarns the public of an existing promotional sale of airfare seats of chartered flights going to Laguindingan Airport inclusive of free testing of Covid-19 allegedly in cooperation with the above-mentioned office or any of its personnel.

DOH CENTER FOR HEALTH DEVELOPMENT - NORTHERN MINDANAO FOREWARNS THE GENERAL PUBLIC OF AN EXISTING PROMOTIONAL SALE OF AIRFARE SEATS OF CHARTERED FLIGHTS GOING TO LAGUINDINGAN AIRPORT INCLUSIVE OF FREE TESTING OF COVID-19 ALLEGEDLY IN COOPERATION WITH THIS OFFICE OR ANY OF ITS PERSONNEL

The Department of Health Center for Health Development - Northern Mindanao calls on the general public to be aware of an arrangement whereby stranded individuals during this time of public health emergency are offered and sold airfare tickets of chartered flights going to Laguindingan Airport coming from other parts of the country packaged with free testing of COVID-19 through the use of FDA approved COVID-19 Test Kits allegedly in cooperation with this Office or any of its personnel.

Please be advised that this Office, as of this date, have not allowed any private individual or entity to offer any promotional sale of airfare tickets with free testing of COVID-19, the results of which shall be read and interpreted by any medical personnel of this Office. Clearly, this is a fraudulent scheme that must be put to a stop.

Should similar offers or representations be made allegedly on behalf of or in cooperation with this Office or any of its personnel, please coordinate immediately with the law enforcement agencies so entrapment measures may be initiated, as perpetrators of fraudulent schemes or transactions may properly be charged with civil and criminal actions under existing laws.
